Notice of Race

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1 Rules

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing and One-design Class rules for boats racing in one-design classes.
- 1.2 Crouch Harbour byelaws will apply.
- 1.3 Open to all dinghies.
- 1.4 Competitors automatically grant to the organising authority without payment the rights in perpetuity to make, use and show any motion pictures, still pictures and live taped or filmed television of, or relating to, this event.
- 1.5 Competitors should note the Organising Authority implements the RYA Racing Charter and they will be required to undertake to sail in compliance with the Charter, which can be found in the front of the RYA rule book.
- 1.6 [DP] Competitors and support persons shall comply with any reasonable instructions from an event official.

2.1 SIs are in the BSC 2024 programme.

3 Communications

3.1 The online official notice board is located at BSC web site.

4 Eligibility and Entry

- 4.1 The event is open to all dinghies
- 4.2 Eligible boats may enter by completing the entry race registration form (available on the BSC website)

- 4.3 To be considered an entry in the event, a boat shall complete an entry race registration form and the owner or helm will have paid their membership fee.
- 4.4 All boats must sign on and off with the race officer or support crew for every race. This can be via What's App, on the paper list situated in the clubhouse, in person to a support crew.
- 4.5 Racing is open to members only.

13 Courses

- 13.1 The courses to be sailed are set in the rivers Crouch and Roach
- 13.2 Marks will be River race marks, Navigation marks and temporary markers.
- 13.3 Courses will be displayed prior to the race for that class on a whiteboard on the pontoon.

14 Penalties

14.1 The scoring penalty RRS 44.1 is changed to read "a two turn penalty is replaced by a one turn penalty".

15 Scoring

15.1 Two races are required to be completed to constitute a series

- (a) When fewer than three races have been completed, a boat's series score will be the total of her race scores.
- (b) When four or more races have been completed, a boat's series score will be the total of her race scores, excluding her worst score.
- (c) When seven or more races have been completed, a boat's series score will be the total of her race scores, excluding her worst two scores.
- (d) When nine or more races have been completed, a boat's series score will be the total of her race scores, excluding her worst three scores.
- (e) When fourteen or more races have been completed, a boat's series score will be the total of her race scores, excluding her worst four scores.

22. Risk Statement

22.1. RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event, each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

23. Insurance

23.1. Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of three million pounds sterling per incident or the equivalent.
